

SC Asks Centre, Sebi for Replies in Sahara-Adani Property Sale Case

New Delhi: The Supreme Court on Tuesday asked the ministries of finance and corporate affairs ministry, and Securities and Exchange Board of India to respond to the Sahara group's plea seeking permission to sell 88 properties, including the 8,810-acre Aamby Valley City project near Lonavala in Maharashtra and the Sahara City in Lucknow, to Adani

Properties. Directing Sahara to implead the union government in its case, a bench led by chief justice BR Gavai asked parties to submit their claims to the court appointed amicus curiae and senior counsel Shekhar Napade regarding the properties sought to be sold by Sahara. "We request the amicus to take help of an assisting counsel who can collate such information in a chart showing proper-

ties which are disputed, where rights are crystallised and where there is a shadow of doubt," the bench, also comprising Justice Surya Kant and Justice M.M. Sundresh.

"The centre also may have to examine and put its thoughts. Request is to implead secretaries of cooperative societies. We can then present our picture," the court said.

Leela Hotels Post 11% Increase in Revenue

New Delhi: Luxury hospitality chain Leela Palaces Hotels & Resorts has reported revenues of ₹333.4 crore in quarter two of this fiscal, up 11% year on year.

The chain reported a profit after tax of ₹75 crore. The chain said its Ebitda grew 17% to ₹161 crore during the quarter under review.

"This marks our fourth consecutive quarter of positive profit after tax, underscoring the strength of our business," said CEO Anuraag Bhatnagar. "Revenue per available room grew 13% reflecting industry-leading performance, driven by improved occupancy and average daily rates, with owned hotels posting strong double-digit revenue per available room growth across both city and resort segments," he added.
